

TERMS & CONDITIONS OF WARRANTY (Valid in Singapore only)

1. This warranty cover against repair of defective materials and manufacturing faults for a period of twelve (12) calendar months from the date of purchase. Ten (10) years motor warranty (labour + transportation charges will be impose from 2nd years onwards). Remote control cover 1 year carry in warranty. (Consumer need to bring the remote control to Winfinity Electric Service Centre for service or exchange)
2. Scope of warranty:
 - a) This warranty card must be filled correctly and posted within 14 days of purchase; otherwise warranty will be void and null.
 - b) The consumer must present this warranty card together with a valid original receipt issued by authorized dealers only.
 - c) Cost of the repairing/ servicing will be charged according upon servicing if warranty card & invoice cannot be produce for verification.
 - d) Manufacturing defects arising from recommended usage as stated in the Instruction Manual.
 - e) Defective parts under the warranty period will be replaced or repaired accordingly. Any parts replaced shall become the property of Winfinity Electric.
 - f) We will accept no responsibility for any injuries to people or animals or damage to objects directly or indirectly resulting from failure to follow the instructions provided in the Instruction Manual.
 - g) Domestic usage within Singapore, warranty will differs if for commercial / industrial usage.
 - h) This warranty card is non-transferable or replaceable even at the event of lost.
3. This warranty does not cover:
 - a) Usage not carried out as recommended or in accordance with the requirements set out at the Instruction Manual.
 - b) The fault is not due to the product's defects.
 - c) The appliance is tempered with repair by unauthorized person.
 - d) The serial number on the appliance is removed, defaced or altered.
 - e) Finishes, Scratches, dents, cracks, noisy, balance of fan, control switch, regulator, blade & blade holder, power point and power plug are not cover under warranty.
 - f) Defects/ damages resulting from accident, misuse, incorrect installation, unauthorized repair, replacement, modification and alteration including usage of regulators/ dimmers.
4. This warranty will be null and void in any of the following events:
 - a) If the serial number on the equipment has been defaced or removed.
 - b) If this warranty card is lost or failure to produce to our service personnel for verification.
 - c) Any unauthorised repair, alteration or modification carried out on the unit.
